## 2013-14 CBA Changes

An open forum meeting was held at Cedarvale Lanes this spring. This meeting was open to all CBA members to attend. The focus of the meeting was to discuss any rule/format changes and to try to gain some insight into how to increase entries without decreasing integrity. The following are changes that were approved and will go into effect immediately (1<sup>st</sup> tournament of the 2013-14 season).

1. Entry fee reduced from \$90 to \$75.
2. Optional Qualifying entry reduced from \$30 to \$25
3. Membership fee reduced from \$50 yearly to \$25 yearly. The \$10 non-member fee remained unchanged.

One of the reasons we were able to reduce fees is due to some increased sponsorship monies. We felt that we could keep a very similar prize fund while decreasing the monthly cost to the membership body. If this attempted reduction in costs is unsuccessful, we will certainly re-visit this at next year's open forum meeting.

Please remember that this is YOUR organization. We need the input from you, the competitors, at these yearly meetings. Your attendance and opinions are very important to the success of the organization.

## Linds Lakers 1<sup>st</sup> & 3<sup>rd</sup> at Minnesota Team Challenge

32 Teams competed in the 2<sup>nd</sup> annual Minnesota Team Challenge held at the Brunswick Zone - Lakeville. The top 8 teams would make the round robin, 2 game total pin fall match play, and the top 11 teams cashed. It took a qualifying score of 2903 (+103) to cash and a score of 2946 (+146) to make match play. Visionary #1 led qualifying with a score of 3149 (+349). The top 3 teams after match play moved into a step ladder finals. When the dust had settled after match play, Storm #1 was the top seed, with both squads of the Linds Lakers being in positions 2 & 3. Linds Lakers #1 came out of the gates swinging and didn't slow down. They shot baker games of 268-248 to easily win the first match of the stepladder against Linds Lakers A, 516-427. They then advanced to bowl the #1 see, Storm #1. The scoring pace of the finals was quite a bit less than the first step ladder match, but the Laker 1 squad was not to be denied, shooting a solid 398 to overcome the Storm teams 377.
